ONLY MHBY EMPLOYEES, CREW MEMBERS OF VESSEL, AND COMPANY APPROVED SUB-CONTRACTORS ARE PERMITTED ON PREMISES TO DELIVER GOODS OR PROVIDE SERVICES TO THE OWNER OF THE VESSEL.
